1. All households are provided as standard, unless otherwise approved, 1 x 240 litre refuse bin plus 1 x 360 litre recycling bin. Additional bins can be provided upon request.
2. A new bin establishment fee is payable as a one off charge for all new bin services. The fee is payable on both new refuse and recycling bins issued. All refuse and recycling bins, including additional bins issued are exempt from GST.
3. The annual rubbish charge for domestic collection and recycling services includes the \$70.00 per tonne State Landfill Levy .
4. MUD fee is based on approximately two units sharing bins. Refer to the MUD matrix of bins requirements.
5. The standard fee also includes 2 x verge bulk waste on-call collections, plus 3 on call mattress collections, access to Bullsbrook Recycling Centre and Malaga Recycling Centre. Tip passes to Red Hill are provided to those not eligible for on-call verge collections.
6. Additional on-call verge bulk waste collections are offered at \$75 per for additional green waste and \$150 per additional general waste collection. Purchase of additional collections are available only to properties that qualify for a verge collection.
