The purpose of each **Community Advisory Group** is to make recommendations regarding funding of both community infrastructure and community initiatives in Ellenbrook and Aveley (including surrounding areas), based on an understanding of local community issues and priorities.

Membership of the Ellenbrook Community Advisory Group (ECAG) and Aveley Community Advisory Group (ACAG) comprises two representatives each from the City of Swan and Ellenbrook Management (Satterley Property Group) or Stockland, and three nominated community representatives from within the community. One of the City of Swan representatives Chairs these meetings, which are held every two months on Monday afternoons/evenings. Community representative positions are held for a period of two years.

2. The Community Advisory Groups attract community representatives that have many different skillsets and life experiences. Please outline the community qualities/experience you would bring to the Community Advisory Group that you are applying for
3. Community representatives often have a vision for their local area. Please share what you would like to achieve from your experience on the Community Advisory Group, should your nomination be successful

### **What happens next?**

The selection process should be completed within approximately four weeks from the closing date. All applicants will be notified by letter of the outcome. If you are short-listed for an informal interview, you will be contacted within four weeks of the closing date to let you know the interview day and time. The interview will be either by phone or in person. If you are chosen as the preferred nominee, an induction will be scheduled before your first meeting.
