6.1 RFT19CP25-SOR - CITY OF SWAN RECYCLABLES RECEIVAL AND PROCESSING

Originating Officer – Colin Pumphrey, Manager, Fleet and Waste Services Reviewed for Compliance - Craig Challis, Procurement Planning Specialist, Contracts and Procurement

RESOLVED UNANIMOUSLY TO:

- 1) **Select** Cleanaway Pty Ltd- Alternative Offer 2 as the preferred Tenderer for the City of Swan Recyclables Receival and Processing RFT19CP25-SOR for the initial period of thirty six months (36) from the date of award for the schedule of rates as per the Tender Offer with the anticipated value of the Contract being two million, four hundred and thirty eight thousand, seven hundred and sixty six dollars and forty six cents (\$2,438,766.46) excluding GST;
- 2) **Authorise** the Chief Executive Officer to enter into negotiations with Cleanaway Pty Ltd and agree minor variations which meet the City's requirement for the City of Swan recyclables receival and processing;
- 3) **Allow** the option to extend the Contract by up to a further two (2) periods, each of twelve (12) months duration; and
- 4) Advise all Tenderers accordingly.

6.2 CONTRACT EXTENSION OF T16SR74-SOR - PROVISION OF A CAT AND DOG COLLECTION AND IMPOUNDMENT SERVICE

RESOLVED UNANIMOUSLY TO:

- 1) Select Julie's Boarding Kennels and Cattery as the preferred Contractor for the *Provision of cat and dog collection, impoundment and disposal service RFT16SR74-SOR* for the extended period of twenty four (24) months from 25 November 2019 until 24 November 2021 with the anticipated value of the Contract being seven hundred and eighty five thousand, two hundred and sixty dollars (\$785,260.00) excluding GST; and
- 2) Advise the Contractor accordingly.
