#### Motion 34:

For issues in regard to illegal parking on footpaths on streets of Dayton, Caversham and Bennett Springs be rectified so users can safely access the path, for example wheelchair users, carers with prams and pedestrians.

# Dianne Arvino – Secretary of the Bellevue Residents and Ratepayers Association, Bellevue

#### Motion 35:

The City of Swan employ a dedicated co-ordinator of the Urban Tree Canopy programme for plantings and maintenance, and maintain a register of plantings and survival rates by suburb.

Reason: The reason for this motion is that while the much needed canopy programme is motoring ahead with some momentum, it seems no one is looking in the rear vision mirror to monitor and maintain previous plantings. It is the hope that a dedicated coordinator will take responsibility for this and provide a continuity which we have not had previously with the everchanging staff allocated to this task.

Lack of continuity caused the Bellevue trees to be left off the watering schedule in their first and second years causing immediate losses. We are still experiencing issues with a blanket policy of we just water for two years which does not take into account the species and weather conditions. More Bellevue trees have now died which were in their third and fourth year which would have been avoided if a coordinator had monitoring on the maintenance schedule.

It does not make economic sense for the City to replace dead trees, which is the policy, when they die after three or four years when monitoring them and applying extra water when needed is a simple remedy, as replanting requires a capital cost and two years of more watering in adhoc locations. Eventually the Bellevue crepe myrtle trees will be drought tolerant and live for over a hundred years but they need more aftercare in the initial five years in monitoring water needs and removing suckers.

It is also apparent that Bellevue is not isolated in experiencing tree losses because of lack of after care and reiterate that employing the right person dedicated to the task that has a horticultural background and takes responsibility for the success measured in survival rates of the urban canopy plantings should remedy this problem. What is happening now clearly needs reviewing.

#### Motion 41:

Elbow of road should be developed and not refilled with gravel (once in 3.5 years).

#### Motion 42:

That the City of Swan initiates an amendment to its Local Planning Scheme to achieve tree protection on private property through the insertion of the following into Schedule A: Supplemental Provisions to the Deemed Provisions Clause 60A:

No person shall remove a tree (which includes ring barking, cutting down, topping, lopping, removing, pruning, transplanting, filling or excavating around, injuring, or wilful destruction) that meets the following criteria unless development approval has been granted in accordance with Part 8 of the Deemed Provisions:

- Tree height of 8m or greater; or
- Canopy width of 6m or greater; or

- A total trunk circumference of 1.5m, and where the tree has multiple trunks average trunk circumferences of 625mm, measured at 1.4m above ground level; or
- On a Significant Tree Register.

As Ms Doutre' was not present at the meeting, this motion was not moved.

Reason: No further information provided.

#### Motion 43:

That the City of Swan commit to a tree canopy target of 30% by 2035 supported by appropriate planning, policy changes, funding, monitoring and annual reporting.

#### Motion 44:

That the City of Swan investigate potential options to incentivise property owners to:

- i. retain mature trees on their private property; and
