- 3. The Bin Establishment Fee 3 is a once off fee for all new bin services for properties with the three bin system. The fee is payable for three bin services issued. General Waste, Recycling Bins and FOGO Bins are exempt from GST.
- 4. The standard service to Residential Properties with a two bin system is 1 x 240L General Waste Bin and 1 x 360L Recycling Bin.
