Fast Track Planning Application Home Business Checklist



When is a planning application required for a Home Business?

A planning application for a 'Home Business' is required in <u>all instances</u>. However, it is important to note that a planning application is generally not required for a 'Home Occupation'.

What is difference between a 'Home Business' and a 'Home Occupation'?

The following table summarises the differences between a Home Business and Home Occupation land use under the City's current Local Planning Scheme No.17.

Home Business	Home Occupation		
 Does <u>not</u> employ more than 2 people <u>not</u> members of the occupiers household; Does <u>not</u> occupy an area <u>greater</u> than 50m²; and Does <u>not</u> involve the presence, use or calling of a vehicle more than 3.5 tonnes tare weight; and Does <u>not</u> involve the retail sale display or hire of goods of any nature. 	 Does <u>not</u> employ any persons <u>not</u> a member of the occupiers household; Does <u>not</u> occupy an area <u>greater</u> than 20m²; Does <u>not</u> display a sign <u>exceeding</u> 0.2m²; Does <u>not</u> involve the presence, use or calling of a vehicle more than 2 tonnes tare weight; and Does <u>not</u> include provision for the fueling, repair or maintence of motor vehicles. 		

How do I prepare my planning application?

The following information is required to be included in your planning application. You may submit your application to City via post or in person. Please note that the City does not currently accept electronic planning applications.

7.	Three (3) copies of a Site Plan drawn to scale	Always
8.	Three (3) copies of a Floor Plan drawn to scale	Always
9.	Three (3) copies of a set of Elevation Plans drawn to scale	Always
