## Dog Exercise and Dog Prohibited Areas <br> In accordance with the Dog Act (1976)

## Dog Exercise Areas

All reserves located within the district, other than those specified in Schedule 1 below, are specified as dog exercise areas for the purpose of sections 31 and 32 of the Dog Act 1976.

This does not apply to -
(a) An area being used for sporting or other activities, as permitted by the local government, during the times of such use;
(b) A car park; or (c) any thoroughfare.

## Dog Prohibited Areas

(1) Dogs are prohibited absolutely from entering or being in any of the places referred to in Schedule 2.
(2) If a dog enters or is in a place identified as dog prohibited or not a dog exercise area including referred to in Schedule 2, every person liable for the control of the dog at that time commits an offence.

## SCHEDULE 2

## AREAS WHERE DOGS ARE PROHIBITED FROM ENTRY

This schedule is subject to any written law and any law of the Commonwealth about assistance animals as defined in the Disability Discrimination Act 1992 (Commonwealth) section 9(2).
(1) Land which has been set apart as a children's playground;
(2) All School Grounds and Kindergartens (This provision does not apply where the dog has a bona fide presence on the premises by agreement with the school).
(3) Shopping premises (This provision does not apply to a dog being taken to or is in a veterinary clinic or pet shop or where the dog has another bona fide presence on that premises).
(4) Wildlife protection areas (where dogs are prohibited by a conspicuously placed notice to that effect); and
(5) Wandoo Heights Reserve (Millendon/Red Hill).
