Licence Application Fees

There are no associated fees in relation to an Alfresco Dining Licence. Initial applications are required to obtain Planning Approval via a Development Application and this does have associated fees. Where a licence is granted it will be renewed automatically upon payment by the Food Business of the City's Annual Food Business Registration Fee unless otherwise cancelled by the Food Business.

Important Information

It is the businesses responsibility to comply with all legislation requirements. The alfresco dining area will form part of the food premises and as such must be maintained to the requirements of the Food Act 2008 and Australia New Zealand Food Standards Code. To assist food businesses meet the requirements the City has developed a number of guideline information sheets. Proprietors should refer to these guidelines to ensure what is being proposed will be acceptable.
